She spoke up, when she felt someone should speak up. Almost reluctantly, one could see her approach the microphone at a national meeting. Reluctant or not, she spoke straight from the shoulder as she shared her thoughts and feelings with her fellow technologists. It was not for her to be still and quiet when word and action were needed.

She is gone now and many will wonder where we can possibly find someone to replace her. We cannot. She herself planted the seeds from which new growth must come. Her strength and support exist within everyone whom she has taught or helped throughout these many years.

We mourn her loss and we are ever thankful that she was and is a part of us.

PRESIDENTIAL NEWSLETTER..... VOLUME ONE...NO. 8

ASRT BOARD MEETING: The spring meeting of the ASRT Board of Directors was held March 5-9, 1980. This newsletter will report on some of the significant items discussed and inform you of some of the decisions and positions taken by your Board of Directors.

AD HOC REPORT ON SOCIETY RESTRUCTURING: The Board considered the report of the Ad Hoc Committee and adopted a restructuring proposal for the membership to review, discuss, and consider at the 1980 Annual Meeting in July. A copy of this proposal will be sent to each member of the Society prior to the Annual Meeting to familiarize them with the concept.

Approval of the restructuring concept does not automatically mandate a change in the structure of the Society. What it will do is provide a direction for the Society to develop new bylaws based upon the restructuring concept for presentation to the membership at the 1981 Annual Meeting of the Society. Only if accepted by the membership at the 1981 Annual Meeting and ratified by the membership at large via a mail ballot would the Society begin implementation of this concept.

Familiarize yourself with this proposal, discuss it with your Affiliate officers and your Regional Directors and come to the 1980 Annual Meeting in Atlanta prepared to consider this important issue.

ARRT NEWS: Neta McKnight, R.T., President of the ARRT informed us that the ASRT Code of Ethics was adopted by the ARRT and will be published in the front of their directory starting in 1981.

Board with a report of a survey conducted by the JRC into the costs of the accreditation process and a comparison of the costs of surveying Collegiate/Affiliate programs with Hospital-Based programs. The Board is studying the report at this time and will respond back to the JRC with inquiries and recommendations prior to the Annual Meeting.

ECE RECOGNITION: ECE participants receiving 100 hours of continuing education in the three year period will be recognized in the SCANNER in addition to receiving their certificate. Additionally, ECE participant's reports will be made available to employers upon request of the participant to the executive office.

ARRT/MILITARY: The ARRT has announced that it will present a one time administration of the ARRT examination to military personnel overseas and evaluate the process and results.

- EDUCATIONAL INQUIRY: The ASRT Department of Education will sending out a questionaire to a random sampling of the radiologic technology community to identify current educational needs and to determine future direction and program development for the Society. If you receive one of these questionaires, please fill it out and return it.
- INNOVATIVE PROGRAMS CAUTION: The Board of Directors cautions students enrolling in "innovative programs" to inquire whether the program has been approved by the AMA and to determine whether or not they will be eligible to sit for the ARRT certification examination upon completion of the program. A complete position statement on this issue will be printed in official publications of the Society in the near future.
- RADIATION THERAPY MANPOWER: The executive office will be conducting a manpower survey in Radiation Therapy Technology utilizing a questionaire developed by the R.T.T. Committee to investigate and report on manpower needs in this specialized discipline.
- RADIATION THERAPY RECRUITMENT BROCHURE: The executive office will be completing work on a recruitment brochure in Radiation Therapy Technology submitted by the Ad-hoc Committee. A target date has been identified for September, 1980 for availability of the brochure.
- CURRICULUM GUIDES: Training Program Curriculum Guides in Nuclear Medicine and Radiation Therapy Technology are entering the final stages and it should have a pre-publication draft available to review at the ASRT Annual Meeting. The revision of the Radiographer Curriculum Guide is undergoing additional changes and may not be ready by that date.
- WILSON SCHOLARSHIP: Procedures and guidelines for operation and implementation of the Wilson Scholarship are being developed by the executive office with plans for dispursement of funds by July, 1982.
- ISRRT MEMBERSHIP: The Board again considered its position with regard to membership in the International Society of Radiographers and Radiological Technicians and reaffirmed its position not to join the ISRRT. Basic membership in this organization would cost the ASRT over \$4000.00 in 1981. Additional costs of sending representatives to Council meetings around the world also was considered in coming to this decision. Our current inflationary spiral and tight money policies in the United States, together with the multiple programs currently undertaken by the ASRT for its membership does not allow us to consider membership in this organization at this time.

However, individual Associate Membership in the ISRRT is available at the cost of \$6.00 U.S.A. dollars per annum. Further information can be obtained by writing to: Mr. E.R. Hutchinson, Secretary-General; ISRRT; 18 Merthyr Road; Whitchurch; Cardiff; CF4 IDG; Wales, United Kingdom.

RE-ENTRY PROGRAM: The standing committee on Education has been charged with developing a curriculum for re-entry into the profession. At present, this program will be limited to Radiography.

- ASRT PUBLIC RELATIONS PROGRAM: The Board of Directors has given the go ahead on a multi-faceted program of internal and external public and professional relations. The highlights of this program include:
 - 1. An increased professional identity
 - 2. A professional membership recruitment campaign
 - 3. A public and professional program of activities integrated with National Radiologic Technology Week and the 1980 ASRT Annual Meeting

Affiliates have already received information related to the Affiliate Poster Display for utilization in local public relations efforts as well as at the ASRT Annual Meeting. Additional information, ideas, and activities related to this program will be mailed shortly from the executive office. Everyone's enthusiasm and participation will ensure success. It is a program that has the National and Affiliate Societies working together in a cooperative effort for the benefit of the entire professional community.

- LEGISLATIVE ACTIVITIES: The executive director and president are scheduled to give testimony before a Senate Committee hearing on S-500. Letters have been sent from the executive office to technologists residing in the areas that Senators sitting on this committee represent urging them to communicate with their Senator and requesting passage of this legislation. The hearings are scheduled for early April. If you receive a letter asking for your assistance, please follow through and communicate with your Senator about this vital issue.
- ALLIED HEALTH ORGANIZATIONS MEETING: The response that ASRT has received regarding our meeting in October, 1979 with other allied health organizations has proved so favorable that the Board has approved a similar meeting to be held in the fall of 1980. The meeting affords ASRT an opportunity to discuss matters of mutual concern and interest and provides for an exchange of ideas, as well as promoting a feeling of mutual understanding and respect.
- AURT/ASRT EDUCATIONAL SEMINAR: On Saturday, July 12th at the time the ASRT usually sponsors the all day Symposium at the Annual Meeting, the educators are in for a special treat. A special seminar for educators has been developed and is being co-sponsored by the Association of University Radiologic Technologists (AURT) and the ASRT. For AURT members, this will be a regular part of their annual meeting. For non-members of the AURT, it will provide a special all day educators seminar and an opportunity to find out what the AURT is. By the way, the AURT is an active supporter of the ASRT. In fact, in order to be a member of their organization, you must be an ASRT member.
- SCOPE OF PRACTICE: A document identifying and describing the Scope of Practice of the Radiographer is in the final stages of development. Work is also in progress on a Scope of Practice for Radiation Therapy, Nuclear Medicine, and Diagnostic Medical Sonography. The membership will be notified as soon as the document is available.

- ASRT ANNUAL MEETING: The 1980 Annual Meeting in Atlanta, Georgia plans to be a most exciting meeting. Registration will begin on Friday, July 11th for the meeting that continues thru Thursday, July 18th. The annual meeting information packet and registration information will be mailed on April 1, 1980. Send in your registration early and don't be disappointed by the possibility of not being able to get your first choice of educational courses.
- STUDENT HANDBOOK: The Board accepted a document submitted by the student activities committee identifying educational program responsibilities to students according to the essentials and guidelines established through the JRC/CAHEA organizations, and plans to develop and publish a student handbook of information in the fiscal year 1980-81. We hope that a better understanding of student's rights and responsibilities during training, as well as a more thorough understanding of the educational and accreditation process will lead to a more informed and responsible student population. The handbook will also include an organizational chart identifying the mechanism and relationship between the ASRT and the JRC and ARRT. Also included will be an identification of the functions, activities, benefits, and rights of student members of the ASRT.
- NEW JOB DESCRIPTIONS: A detailed, comprehensive document of job descriptions was submitted to the Board by the sub-committee of Professional Activities. The document includes job descriptions for new classifications and all imaging modalities, updating an earlier document adopted in 1972. The Board is currently reviewing the document and plans for a final draft to be considered for adoption by the Annual Meeting. Our sincere appreciation to the sub-committee and all members of the Society who participated in this important project.
- RADIATION OCCUPATIONAL EXPOSURE SURVEY: The Board reviewed a letter of concern related to possible occupational related cancers from a group of technologists. Included with their letter was a request that a questionaire/survey be conducted into the incident of cancer and other health related conditions and occupational exposure to radiation. The Board of Directors moved to print this questionaire in an upcoming issue of the SCANNER. We urge all technologists to review the questions carefully and respond back to the ASRT. Upon compiling of the results, the ASRT can utilize this information, if warrented, to push our demands for a more comprehensive, detailed survey of the profession by public or private agencies.

GOVERNMENT PUBLISHED FACTS ABOUT MISSOURI and RADIATION

Did you know that Missouri had a professional staff of 3 (three) professional persons in the Radiation control program with a budget of \$68,000 (figures for fiscal year 1978). Staff was increased to 4 (four) persons and \$143,000 in fiscal year 1979.

At this time (1980) Missouri has neither an NRC agreement or an OSHA approved plan. The "Show me state" needs to be shown!!

Despite widespread recognition of the hazards of radiation, no comprehensive program exists to protect the public from the hazards radiation presents.

According to an OSHA official, radiation does not have a high priority in OSHA's inspection effort because many sources of workplace radiation are not readily identifiable. For example, the Standard Industry Classification Code, used by OSHA for identifying and grouping many industries, gives no indication whether the industry uses any form of radiation.

More good news:
Over 11,700 new diagnostic X-ray systems were reported to FDA in fiscal year 1978. During the same period, FDA and 22 states under contract made 3,152 field tests. They found 1,918 installations that were not in compliance with FDA's standards, including 32 violations which warranted ceasing operations, and 1,119 other major violations which warrant cessation as "conditions which pose an immediate radiation hazard to the public health and safety".

MISSOURI

The division of health has responsibility for radiation control. The division established regulations for all sources of ionizing radiation. Sources of nonionizing radiation were not regulated.

The division of health assigned its responsibility to the Bureau of Radiological Health. The Bureau is the only State agency that has the authority and responsibility for radiation control. Its radiation control program included X-ray equipment and NARM. In addition the Bureau does some environmental surveillance and microwave inspections upon request.

The Bureau spent \$68,455 on its radiation program in fiscal year 1978. This expenditure basically covered its staff of three professionals--one supervisor and two inspectors. Later, the Bureau increased its staff to include four inspectors. Its budget for fiscal year 1979 was \$143,209.

Missouri has neither an OSHA-approved plan nor an NRC agreement. The only FDA program which the State participated in was the BENT program.

Compliance programs

As of March 31, 1979, there were about 4,300 X-ray facilities with about 5,900 machines and 74 NARM facilities registered. The State required all users to register within 30 days of acquisition of a radiation source. The registrations are to be renewed every 2 years. According to State officials, there had never been a registration canceled or denied.

During our review, legislation had been proposed which would permit Missouri to enter into an NRC agreement. The Bureau administrator estimated that it would cost \$120,000 for the first year of operation.

The State used several sources, including NRC's material licenses, the State Board of Registration for the Healing Arts, and FDA's X-ray assembler reports, to identify users in the State who should be registered. Renewals were generally made during an inspection. The State was making an effort to identify NARM users and had increased its registrations from 47 on June 30, 1978, to 74 in March 1979. The State has actively sought to register NARM users because it plans to implement a compliance program for NARM users in fiscal year 1980.

The State's inspection frequency goals were to inspect hospitals every 2 years and physician's and dentist's offices every 3 years. In fiscal year 1978 the State inspected 278 facilities having 766 machines. State data showed only 13 machines with deficiencies. According to the administrator, this does not represent total deficiencies found because, where possible, deficiencies are corrected during the inspections and never documented. Deficiencies are not classified as to seriousness, and penalties are not levied.




