

The minutes of the January meeting were accepted with the correction that Connie Huesgen had resigned as Education Committee Chairman.

Treasurer's Report Kathy Parsons submitted a written report for the second quarter of our 1985-1986 fiscal year. She noted the donations that had been received for the Scholarship fund. Secretary Lee Ann Ackerman was asked to send thank you letters to those people who made the donations. Updated membership lists were available for the Board members.

Membership Committee: Motion #1: I move the MSRT Life Membership qualifications be as follows:

- 1. Active MSRT member for fifteen (15) years
- Service on the Board of Directors for five (5) years, to include officer or direct board position

Moved by Barbara W. Hente second by Lee Ann Ackerman. Discussion followed, motion carried.

Motion #2: (this is a motion to investigate the qualifications of various members for the purpose of their elevation to Life Membership Status at the 1986 Annual Meeting) Motion made by Michael D. Ward second by Lee Ann Ackerman. Discussion followed, motion carried. Linn Neely will investigate and report back at the July Board of Directors meeting. Motion #3 to provide any new Life Member with a permanent membership card (made by Barbara Hente second by Kathy Parsons) was found to be a duplicate motion to one already in effect.

Motion #4: I move the MSRT Honorary Membership qualifications be as follows:

1. Ongoing support of the MSRT in various ways such as being a supportive member, annual meeting support, etc.

Unusual contributions to the Society or the profession.

Moved by B. Hente second by K. Parsons. after discussion the motion carried.

Motion #5: (this motion was to investigate the qualifications of various persons for possible elevation to Honorary Member status at the 1986 Annual MSRT meeting) Motion made by B. Hente, second by K. Parsons. After discussion motion carried. Barbara Hente was asked to investigate the qualifications of these persons and report at the July Board meeting. Ways and Means Committee A written report was submitted by Barbara Hente, Committee Chairman. She reported that the raffle tickets have been printed and they were available for distribution at this meeting.

RADIOGRAPHER: A written report was submitted by Editor, Barbara Hente.

Nominating Committee: Chairman Jennifer Ewert reported she is in need of mailing labels. She asked permission to investigate xerox label copying. Jennifer noted she needs updated officer position duties to send to those nominated so they will

know the duties of the various offices. Norman Hente will forward the appropriate changes. Discussion took place as to exactly which categories of MSRT membership may nominate for office. It was suggested to allow students to nominate. Since there was no motion, discussion ended.

District Reports

Fourth District: A written report was presented by Barbara Hente. Motion #6: I move Eileen FitzGibbon and Lee Ann Ackerman be approved as 1987 MSRT Annual Meeting Co-Chairmen. Moved by B. Hente with second by Michael D. Ward. Motion carried.

Fifth District: Nikki Thielmann gave an oral report. Seventh District: Jennifer Ewert presented a written report.

Recess: 12:10 for lunch, reconvene at 1: 50 p.m.

Region V Report Norman L. Hente, Region V Director could not be present as he was attending the Kansas Society Annual Meeting. President Fulmer reported she was in receipt of a letter from Debra A. Hurst, one year delegate to the ASRT House of Delegates, resigning from that position. Barbara Hente was appointed to fill the vacancy. Pam further requested that Barbara represent the MSRT as the Affiliate Delegate to the ASRT Annual Meeting.

Correspondence President Fulmer reported that we have received information from Regional Director Norm Hente that he will be attending our 1986 Annual Meeting as the ASRT Representative. A letter received from the American Association of Medical Assistants was referred to our Regional Director for appropriate action. President-Elect Ruby Givens passed around the copy of the ASRT Affiliate Newsletter she received. Ruby asked why there was no news of the MSRT in this publication, the answer was that no member of the Board had send any in for publication. President Fulmer assigned the duty of submitting information to the ASRT Newsletter and Scanner to Ruby. Pam passed around the ASRT Educational Foundation Packet she received and suggested that some of the information contained in this packet be published in our journal.

Convention 1986 Convention Chairman James Watson submitted a written tentative program, and proposed fee schedules. After discussion it was voted to have member pre-registration set at \$125.00. Jim asked the Board for direction as to sending 1986 meeting information to ARCRT members, for their possible attendance at the meeting. The Board agreed that the ARCRT members should be included in the Convention mailing.

Jim also reported that there had been some rain damage to the viewboxes in storage. Following discussion permission was granted to Jim to inspect the stored viewboxes and repair or discard them as needed. Jim further noted that he was approached to buy single viewboxes. The Board decided to trade for a donation to the Scholarship Fund, as opposed to selling them.

Jim reported that a preliminary informational mailing will go to members on June 15th, with the final registration packet to be mailed July 15th. Ruby suggested we survey attendees to determine how their registration was paid (personal/employer paid). Convention 1987 A general outline of the program and facility report were presented by 1987 Annual Meeting Co-Chairman Lee Ann Ackerman. She reported that the Fourth District recommends the Holiday Inn-Westport as the hotel facility.

Unfinished Business Ruby reported no information was available on contracts for viewboxes at this time. Ruby also presented a sample of new stationery. She will investigate the cost and report at the July Board Meeting.

Motion #7: I move that the board institute a method of showing appreciation to board members and committee members - see attached sheet. Motion made by Ruby Givens, second by Nikki Thielmann. (Of note here: the attached sheets contain the list of officers and chairman with a proposed "recognition" in the form of certificates/placks/pins, etc.) Motion tabled until July to allow for changes directed by the Board. The Board looked at a picture that could be donated to the ASRT office in Albuquerque, N.M. Pam directed Linn Neely to make the appropriate contacts to determine if the picture was available, what the cost would be, etc. President Fulmer reported that the MSRT Articles of Incorporation renewal notice will be sent to Debbie Hurst.

Parliamentarian Ulysses D. Murray expressed that he did not think it proper to award pins and other awards to officers who were elected but did not fulfill their responsibilities and duties to the Society.

Counselor Reports: Western Counselor, no report. Eastern Counselor, Michael D. Ward reported that he has approved speakers for the Fourth District. He has also responded to requests for membership applications.

Delegate to the ASRT House of Delegates Michael D. Ward asked if there was any specifics that the Board wanted him to bring to the House of Delegates. The only suggestion was to include the ASRT ID# on the ASRT membership cards.

New Business: Motion #8: I move the MSRT donate \$50.00 to All Saints Episcopal Church as a memorial for Marguerite Murray (wife of MSRT Life Member, Ulysses D. Murray, R.T.). Made by Barbara Hente with second by Michael D. Ward. Motion carried.

Motion #9: I move the MSRT institute a Student Technologist Student Bowl to begin at the 1987 Annual Meeting in St. Louis. Made by Barbara Hente second by Lee Ann Ackerman. Motion defeated.

Reports requested at the Post-Convention Board meeting with an April Board meeting deadline were presented at this time. Barbara Hente submitted written copies for the Board of the general calendar for the raffle preparation. This included samples of previous raffle tickets, costs, distribution, etc. Barbara also pro-vided written copies of Essay Chairman Duties with copies of judging sheets; also presented were written copies of the Exhibit Chairman Duties. Barbara noted that these are separate chairmen, but may be combined and chaired by the same person.







NOT-FOR-PROFIT ORGANIZATIONS: IRS CLASSIFICATION

There are several classifications of not-for-profit Corporations as defined by the Internal Revenue Service under section 501 (c) of the Internal Revenue Code.

Those corporations falling under section 501 (c)(3) of this code are entities organized and operated exclusively for religious, charitable, scientific, or educational purposes.

In order to qualify for tax exempt status, an organization must be described as organized and operating exclusively for one of the specified purposes listed above.

The ruling from the Internal Revenue Service is that ASRT and its affiliate societies are not exclusively educational or scientific, "but are primarily for the benefit of your members and the members of your affiliate societies in furthering their business interests, professional capabilities, and the development of a higher degree of efficiency in operation." Therefore, the interpretation of the Internal Revenue Service is that the ASRT and its affiliate societies do not qualify for exemption under section 501 (c)(3) but qualify for exemption under section 501 (c)(6). This essentially means that the ASRT and its affilliated societies do not pay federal income tax, but may pay other taxes. For example, the ASRT does pay state sales tax.

A common inquiry of the ASRT office is in regard to the affiliate societies receiving a bulk rate permit for mailing. Such permit is based upon your IRS classification. In order to receive a bulk rate permit for not-for-profit corporations, you must be classified under section 501 (c)(3). ASRT and its affiliate societies are not classified under section 501 (c)(3), but 501 (c)(6).


Although some states do list the affiliate society as a not-for-profit corporation and the affiliate society is given a tax exempt number as far as sales tax purposes are concerned within that state, still the affiliate society must abide by the Internal Revenue Code and for this they are classified as 501 (c) (6).

ASRT and its affiliate societies are required to file annually, form 990, which is the return for organizations exempt from income tax. The form 990 must be filed when the affiliate society realizes annual gross receipts of more than \$10,000.
