## MANPOWER ISSUE RECEIVES NATIONAL ATTENTION

Manpower shortages in the medical imaging profession made front page news in the Wall Street Journal and prominent coverage in the New York Times. Both publications ran articles in their August 27, 1991 issues. Brief descriptions of the various types of imaging specialists were defined (ultrasound, radiation therapy, general diagnostic, MRI, etc.); training requirements and general salary rates were also mentioned. Most importantly, the reports focused on the medical imaging boom and that the subsequent manpower shortage is a serious concern to health care industry executives throughout the United States. Also, the Times article stated that the U. S. Labor Department predicts at least 70,000 more jobs for radiologic technologists will be created by the end of the 1990's. Radiologic technology programs and the current lack of enrollment in such programs was also briefly discussed.

### M.S.R.T. SEEKS MALLINCKRODT AWARD OF EXCELLENCE NOMINEES

#### General criteria:

- 1) The final selection will be made by the Awards Selection Committee from candidates provided by the Board of Directors.
  - 2) Candidates shall have a minimum of five (5) years of consecutive and current membership in the M.S.R.T.
- 3) Candidates shall be: a) a registered technologist b) supporting member c) other such as a physician or other interested participant d) non RTs who have made unusual or exceptional contributions
- 4) All candidates shall have outstanding contributions to the M.S.R.T. above and beyond those normally required by the M.S.R.T. (example recruiting several new members for several years).
- 5) Technologist candidates for this award may have been previously honored with Life Membership or invited lectureship; they may have served as officers / committee chairman. Candidates may be considered who have not been previously honored.

#### General information:

6) a) "Missouri Society of Radiologic Technologists" shall be spelled out on the plaque presented to award winner b) the name of the winner will be presented by the committee to a representative of Mallinckrodt Diagnostics at least four (4) weeks prior to the Annual Meeting c) candidate nominations shall be open to all M.S.R.T. members and must be forwarded to the Board of Directors meeting of the year in which they are to be considered, mailed to P.O. Box 14333, St. Louis, Missouri 63118 d) the "Master Plaque" will be housed by the Historian and brought to each Annual Meeting for display.

## L.A.C. BRACES FOR 1992 LEGISLATIVE SESSION

The late fall and early winter months have been buzzing with activity as the Legislative Activities Committee began their third consecutive year of strategies and negotiations in helping to develop a substantial and acceptable legislative package in order to secure licensure / certification for radiologic technologists in the state of Missouri.

As in the past, the process has been much the same. November and December of 1991, as well as January of 1992 provided the time-frame in which representatives of the M.S.R.T., Missouri Department of Health, Division of Legislative Research, and various Physician, Hospital, and Allied Health organizations assembled for several meetings at the State Capital Building in Jefferson City, Missouri. Under the guidance of State Representative Carole Roper-Park (52nd District - Sugar Creek, Missouri) and after many hours of deliberation, the final draft was completed in mid - January.

This legislative package was presented to the M.S.R.T. Board of Directors at the January 25, 1992 meeting which was held in Overland Park, Kansas. Having reviewed its contents, the Board has agreed to support this legislation in general, but will also forward to State Representative Roper-Park a formal recommendation for some changes to the existing draft.

As this issue goes to print, this legislative proposal has been filed and has been assigned a number. The following is a brief synopsis of the current bill.

#### **HOUSE BILL 1592**

House Bill 1592 concerns the training of individuals who administer ionizing radiation for diagnostic and / or therapeutic purposes to human beings.

The Missouri Department of Health will issue regulations establishing minimum training standards. The regulations will establish training standards for the various categories of radiologic technologists and will take into account appropriate professional or trade certification or accreditation.

These regulations will not apply to physicians, chiropractors, dentists, and podiatrists.

An Advisory Board will be established for 18 months in order to advise the Department of Health regarding the implementation of this bill.

The Board of Registration for the Healing Arts, the Dental Board, the Board of Chiropractic Examiners, and the Board of Podiatry will each establish by regulation a system of certification for individuals administering ionizing radiation outside of a hospital setting under the supervision of a physician, dentist, chiropractor, or podiatrist, respectively. The regulations developed by the respective boards will be at least as stringent as those established by the Department of Health.

Individuals meeting certain established criteria are eligible for certification under a "grandfathering" clause.

A practitioner who knowingly allows an uncertified person to act as a radiologic technologist or interprets the work product of an uncertified person will be subject to licensure disciplinary action.

The Division of Professional Registration and Department of Economic Development will maintain a central registry of those individuals certified as radiologic technologists by the various licensure boards.

Hospitals may only employ certified radiologic technologists.

The Legislative Activities Committee strongly urges you to write or telephone your State Representative or Senator for a complete copy of House Bill 1592, and as importantly, request that they support this legislative package. State Representative Roper-Park has also asked our organization to encourage legislators to serve with her as co-sponsors to this bill.

As concerned professionals we have an obligation to our patients, our colleagues, and to all citizens of Missouri to provide the highest quality of health care and safety.

As this issue goes to print, House Bill 1592 has been referred to the Committee on Economic Development and Professional Registration. This committee, which will hear H.B. 1592 in the very near future, is being chaired by State Representative Joseph Treadway. The M.S.R.T. has been encouraged to contact State Representative Treadway and to voice our support.
